#### **8.2. Exposure controls**

#### 8.2.1. Engineering controls

For those situations where the material might be exposed to extreme overheating due to misuse or equipment failure, use with appropriate local exhaust ventilation sufficient to maintain levels of thermal decomposition products below their exposure guidelines. Therefore, the health effects associated with titanium dioxide are not expected during the normal use of this product.
